This Privacy Policy describes how **Shazarch s.r.l.**, an Italian company with its registered office in Italy (“**Shazarch**,” “**we**,” “**us**,” or “**our**”), collects, uses, shares, and protects personal information in connection with the TadarC mobile applications (iOS and Android) and the websites <https://www.shazarch.com> and <https://www.tadarc.app> (collectively, the “**Services**”).

By accessing or using our Services, you acknowledge that you have read and understood this Privacy Policy.

2. Scope of This Policy

This Privacy Policy applies to:

- TadarC iOS and Android applications;
- Our websites www.shazarch.com and www.tadarc.app;
- Related marketing and communication activities.

This Policy complies with:

- **EU General Data Protection Regulation (GDPR)**

 - **ePrivacy Directive**
 - **California Consumer Privacy Act (CCPA)** (for users in California, USA)

3. Categories of Data We Collect

We collect the following categories of information depending on how you use our Services:

- **Account and login information:** when logging in with Google, Apple, or Meta accounts.
- **Device and technical information:** device model, OS version, IP address, ad identifier (IDFA/AAID), browser type.
- **Usage data:** app interactions, session duration, pages visited, in-app behavior.
- **Precise location data:** collected and shared with Google Places services where required for app functionality.
- **Cookies and trackers:** on the website, via CookieScript consent platform.
- **Analytics data:** via Google Analytics and Firebase.
- **Payment-related data:** limited to confirmation of successful transactions (payment processing is handled by third parties).

We do **not** display third-party ads inside the app.

4. Legal Bases for Processing (GDPR / UK GDPR)

We process personal data on the following legal bases:

- **Contractual necessity:** to provide the Services (e.g., authentication, functionality, support).

- **Legitimate interests:** to improve our Services, analytics, and security.
 - **Legal obligations:** to comply with applicable law.
 - **Consent:** for location tracking, cookies, and marketing communications.

5. Purposes of Processing

We use personal data to:

- Provide, maintain, and improve the Services;
- Authenticate users and enable account login;
- Provide customer support;
- Analyze usage through analytics tools;
- Ensure compliance with security and legal requirements;
- Send marketing communications or measure advertising campaigns, where consent is given.

We do not conduct interest-based advertising inside the app.

6. Cookies and Tracking Technologies

- **Website:** We use cookies and tracking technologies via CookieScript. Non-essential cookies are set only with your consent.
 - **iOS:** Tracking is subject to Apple's AppTrackingTransparency framework.
 - **Android:** A consent mechanism will be implemented to comply with GDPR.
 - Users can manage cookie preferences through their browser or device settings.

7. Data Sharing and International Transfers

We may share your data with:

- Service providers (Google Cloud, Firebase, analytics, geolocation APIs);
- Legal authorities where required by law.

Data may be transferred outside the EEA (e.g., Google Cloud infrastructure). Transfers rely on **standard contractual clauses** or other adequate safeguards.

We do not sell personal data.

8. Data Retention

We retain personal data **as long as necessary** for the purposes described in this Policy, including to comply with legal obligations, resolve disputes, and enforce agreements.

9. Children's Privacy

Our Services are accessible to children aged **4+** in some jurisdictions.

- For users under 16 in the EU/EEA, parental consent is required where applicable.
- We do not knowingly collect personal information from children without legally required consent.
- If we learn that we have collected such data improperly, we will delete it promptly.

For U.S. users, we comply with **COPPA** where applicable.

10. Your Rights Under GDPR / UK GDPR

You may exercise the following rights at any time:

- **Access** your data;
- **Rectify** inaccurate or incomplete data;
- **Erase** data (“right to be forgotten”);
- **Restrict** processing;
- **Object** to processing;
- **Data portability**;
- **Withdraw consent** at any time.

We may require proof of identity to process your request.

11. Additional Rights for California Residents (CCPA)

If you reside in California, you have the right to:

- Know what personal information we collect and how we use it;
- Request deletion of your personal information;

- Non-discrimination for exercising your rights.
